- 2) 如申請人於「統一註冊日期」後獲取錄，仍須以「註冊證」/「入學許可書」註冊。如申請人在一所幼稚園註冊後打算轉校，須到原先註冊的幼稚園取回「註冊證」/「入學許可書」。申請人如由其原先註冊的幼稚園取回「註冊證」/「入學許可書」，即代表該幼稚園不會再為該兒童保留學位。其原先註冊的幼稚園不會退還「註冊費」。
- 3) 2025-26 年度註冊費為\$ 1,570

01/2025	Parents register with one KG during the Centralised Registration Dates (i.e. 2 to 4 January 2025) by submitting the RC / AP and paying registration fee	Parents refer to the K1 vacancy information released by EDB after the Centralised Registration Dates (i.e. from early February 2025) and apply for admission to other KGs	Children who have not been notified of admission will receive a notification letter, and if there is a vacancy, parents will be notified individually by phone. *Parents need to go to the kindergarten for registration at the designated time, and submit the original registration certificate and registration fee. Registration Dates (2 to 4 January 2025)

- 1) If parents cannot present the “RC” / “AP” to the KG their child has been admitted to during the “centralised registration dates”, the KG concerned may not be able to complete registration for their child. Hence, parents are required to submit “RC” application to EDB within the designated period.
- 2) If an applicant is admitted after the “centralised registration dates”, he/she is still required to submit the “RC” / “AP” for registration. If an applicant wishes to change school after registering with a KG, he/she is required to get back the “RC” / “AP” from the KG with which he/she has registered. Upon getting back the “RC” / “AP” from a KG, the KG concerned will no longer reserve the place for the applicant. The registration fee paid to the KG with which the applicant has registered will not be refunded.
